All electronic comments must be submitted before noon on the day of the meeting. The information you provide will be collected and retained per Oregon Revised Statutes (ORS) Public Records Policy 192.005 to 192.170 and 357.805 to 357.895. In some limited cases, the information may be exempt from these regulations.

Visitors may state their comments and should not expect the governing body to discuss the statement or issue in back-and-forth dialogue.
